This AGREEMENT by and between DAN T. KEEN of KEEN EQUINE SERVICES, INC. "TRAINER" and (OWNER OF HORSE) is for the training services of "OWNER" or person responsible for horse referenced below. HORSE NAME______

UPON DELIVERY OF HORSE(S), OWNER must present a copy of negative coggins and first months payment. (no refunds for early pick up). OWNER agrees that the training services will be for a term of 30 days for the total amount of \$1,800.00 (pasture) \$2,100.00 (stall) STALLIONS are an additional fee of \$300 (PLEASE CIRCLE PREFERENCE) (prorate extra days) will include feed, training and board, all incidentals will be an extra charge (are subject to change without notice). Please be mindful that trainer will take the liberty to haul horse to different locations for exposure AND care for horses feet/worming/administer medications or vet services as needed. TRAINER will house OWNERS horse (according to owner's boarding preference) where TRAINER see's fit according to the behavior, mind, and diet of each horse and their needs. Absolutely NO drop in's, but appointments only (due to the tight training schedules and routine of all horses in training).

REQUIRED to have a credit card on file as backup payment if necessary (CC form below). Monthly billing cycles occur and FULL payment is due on or before horses departure. Forfeiting your horse after 3 months of nonpayment to TRAINER may occur, with a 10% service fee of total bill to be added at time of pickup. Venmo, e-check, check or CC (service charge will apply to owner)

Under Texas Civil Practice And Remedies Code Title 4 (CHAPTER 87) as well as HORSE OWNER agrees that TRAINER, PROPERTY OWNER and TRAINERS EMPLOYEES or AFFILIATES shall NOT be held responsible for injuries or death to OWNER or OWNER'S family/friends/trainer/representatives and OWNER'S HORSE(s), including all health problems, all accidents, loss due to theft or death, etc. that might occur while in TRAINER'S custody and therefore OWNER will assume ALL inherent risk. This agreement covers release of liability of TRAINER, PROPERTY OWNER and TRAINER EMPLOYEES or AFFILIATES from death or any/all injuries that may occur to OWNER, OWNERS HORSE and/or OWNERS FAMILY/REPRESENTATIVES whatsoever at, all while in TRAINERS custody. Everyone 18 years of age and younger are required to wear a helmet and those over the age of 18 are recommended to wear one, otherwise OWNER will take full responsibility, including all financial risk, for any/all decisions pertaining to the helmet requirements. If horse is set back in training due to injury, you will be charged a board rate of \$30 per day plus managing injury fees (see below)

In the event of an accident or injury to horse(s), OWNER gives TRAINER permission to contact TRAINER'S veterinarian to provide medical services at OWNERS expense. TRAINER, PROPERTY OWNER and anyone representing TRAINER will use best judgement in the event of an emergency and will not be held accountable financially whatsoever at all. OWNER will respect decisions made in accordance and will be held accountable for slanderous and/or negative remarks made publicly regarding incident, thus possibly incurring charges of slander in a court of law. Video taping is strictly prohibited, unless written consent is provided by TRAINER, and video will not be permissible in a court of law. OWNER agrees to indemnify and hold TRAINER and/or PROPERTY OWNER harmless and defend for any damages caused by OWNER'S horse or OWNER to property or any other man/women/person(s) and for any indirect or consequential damages that may occur as a result.

In the event a dispute shall arise between the parties related to OWNER/OWNERS HORSE or anyone representing or accompanying OWNER hereby agrees to resolve before taking legal action, and if the two parties cannot agree, the dispute shall refer to original and organic constitution (of 1787 as amended in 1791 with the bill of rights) "for" The United States of America in which to resolve. If conflict cannot be resolved, OWNER shall fund council/attorney of TRAINER, PROPERTY OWNER and/or their REPRESENTATIVES (defendants choosing) and all court cost until a resolution is met by all. For OWNERS convenience, my contract and pricing are subject to change, updated frequently and viewable on my website. If you are having trouble viewing changes or have inquiries, please reach out to TRAINER via text or email for an updated copy.

TRAINER request OWNER NOT leave equipment and tack while horse(s) in training. Blankets during cooler months and supplements ARE permissible for additional fees and can be picked up by OWNER.

ADDITIONAL FEES: Bute/Banamine-\$15 (dose), Administering supplements/medications-\$5 (daily), Bandaging-\$20 (per time), Blanketing-\$50 (month), Worming-\$30, Shoeing (inquire for price), Visitation-\$50, Hourly Lesson-\$200

FIELD TRIPS: additional \$35 per outing to take horse to other facilities for further training/exposure. Average 2-4 times a month

PLEASE NOTE * Horse are put through a vigorous training program and may lose weight as progress happens. This is not a SHOW-barn, it is a horse training facility and, if you are signing this, you have significant needs pertaining to the training of your horse, in which you have not been able to accomplish on your own. The "ideal" length of time for training a horse is from 3 to 9 months depending on problems or goals. Longevity of the horses training program is dependent on owners willingness to learn Dan's program and continue what Dan has designed for each horse. If horse is picked up before 90 days there is a good chance the horse will not retain what it has learned. Training is reinforced with repetition and there are no money back guarantees and no refunds on services already rendered. If you decide to have Dan broker/sell your horse or you purchase a horse from Dan, you are in agreement of your own free will, having ample time to do your own due diligence and understand that Dan has represented the horse to the best of his knowledge and will not be held financially responsible, in any way, after the fact. Please address all concerns before purchasing or consigning your horse.
